Vocab	Definition
<b>Witchcraft</b>	The practice of magic and the use of spells to contact supernatural beings, often considered as a malevolent activity.
<b>Hysteria</b>	Exaggerated or uncontrollable emotion or excitement, especially among a group of people.
<b>Accusations</b>	Charges of wrongdoing; assertions that someone has done something illegal or morally wrong.
<b>Puritanism</b>	(In this context) The beliefs and practices associated with the Protestant Reformation which stressed extreme moral and religious values.
<b>Trials</b>	A formal examination before a competent tribunal, which may result in retribution or judgment based on evidence.

# Contextual Usage

1. The accusers targeted innocent individuals with false **accusations** of **witchcraft** out of **hysteria** and fear.
2. Many people were put on trial during the Salem Witch **Trials**, facing false **accusations**.
3. **Puritanism** strongly influenced the beliefs and practices at that time.

## ESL Warm-up Activity

To capture students' attention and set the tone for the lesson, start with a roleplay activity. Divide the class into two groups: "Accusers" and "Defendants." Each group will have 5 minutes to prepare their roles. The Accusers will need to come up with fictional accusations of witchcraft against individuals in the Defendants group.
